## THINK OF THE WORLD'S MOST MEMORABLE BRANDS.

You can picture the logos and names of these companies so clearly because they are always the same. Everywhere.

**A successful company's logo and its name have to be consistent—online, on store windows, and on packaging materials.**

This consistency reinforces the essence of that company. The same goes for Avon. It's why we are one of the most recognisable brands in the world.

**When people see our logo or read our brand in its familiar font—whether in London or Sao Paulo—it creates a certain feeling for them, a familiar emotion.**

That's the goodwill all of you and the generations of Representatives before you have built together. That goodwill we've all worked so hard for may be damaged if the Avon name is used in a way that isn't consistent or doesn't represent Avon in the best light possible.

**To protect our brand and your Avon business, we've developed easy-to-follow guidelines on how to use the Avon name and trademark when you create your own advertising materials and marketing tools, either online or offline.**

The Avon name, logos, brands, product names, and even the look and feel of Avon's packaging are all types of trademarks, most of which are protected by law. Such trademarks are changing over time, and it's very important for us to always use the most current ones.

No one can use these trademarks to sell or advertise products, to recruit reps, create promotional items, or engage in any other business in which we are engaged, without our permission.



## INDEPENDENT REP

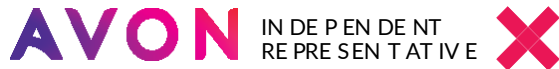
As an **Independent Avon Rep (Wakil Berdaftar Avon)**, Avon permits you to make certain uses of its trademarks, but only as specified by these **marketing rules of conduct** and any other updated by Avon Malaysia.

**Over the next few pages we'll show you the correct way to use the Independent Avon Rep logo.**



## LET'S SEE SOME BASIC RULES

**IMPORTANT NOTE!** Whenever you're permitted to use an Avon brand logo, you must use the correct and current version. Please do not use any previous versions shown below:



When using the Avon brand logo, you must also have the words **INDEPENDENT REP** as close to the logo as possible, or use the official version shown below which can be accessed on <https://shop.avon.my/RepMarketplaceSelling>

**DO NOT USE** the **Avon name** or **brand logo** to create your own promotional items, such as hats, t-shirts, roll-ups or other 'swag'.

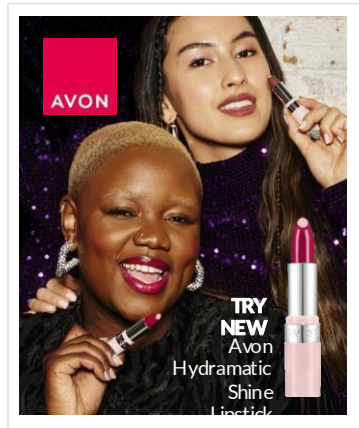

**WE DO PROVIDE** official promotional items and sales tools for Reps, which are sold as premiums via our Brochures, and we encourage the use of these.

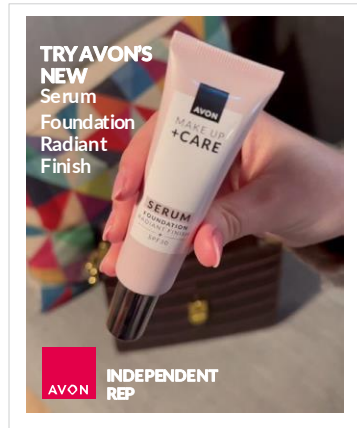


# PRINT MATERIALS

**DO NOT USE** Avon's corporate logo or copyrighted images when creating your own printed materials, such as flyers for canvassing. In order to make it clear that the printed material is your own advertisement and it was not created by Avon, be sure to use the **Independent Avon Rep** logo.

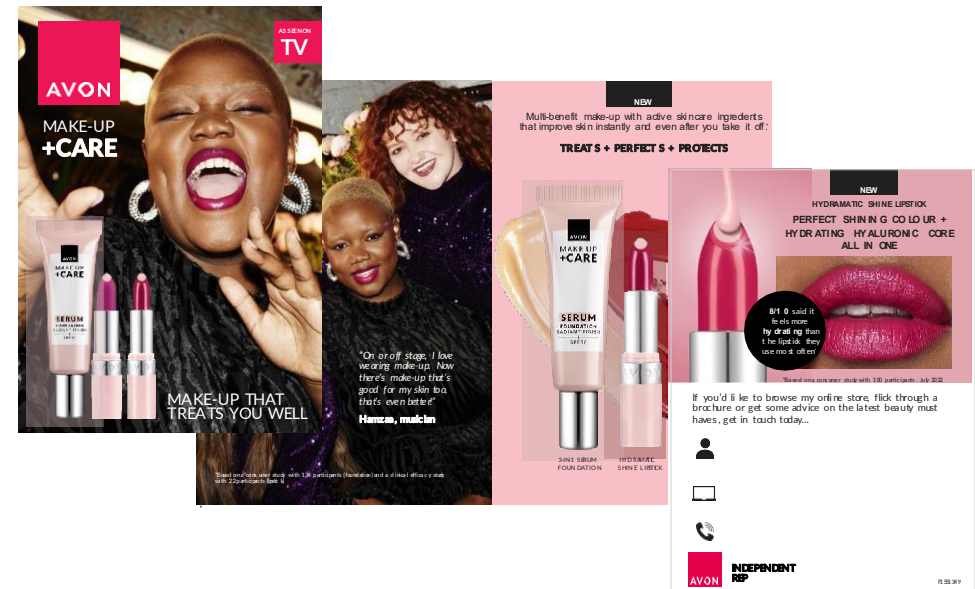

**WE DO PROVIDE** print materials such as canvassing cards for some of our top product launches, which can be personalised with your information, and make your status as an **Independent Avon Rep** clear. Avon will inform if such material are available for use.





## DOMAIN NAMES, URLS AND E-MAIL ADDRESSES

Representatives may not register domain names containing **Avon's trademarks** (including the word 'Avon') and may not use Avon's trademarks in any subdomain or non-domain portion of any URL without our written approval. This is because it might create the false impression that the website or email address is managed by Avon.

If you already have a website with Avon or another Avon trademark as part of the domain name, you will need to change the domain / account name. If you fail to do so, Avon may require you to move your website to a different domain and transfer your domain to Avon.

# ALL ABOUT COPYRIGHT

Avon's **photographs, brochures, catalogues, sales material, contracts** and **sales training sessions, literature, audio or video material, presentations** and **events** are copyright-protected property, just like an author's book, an artist's painting, or a composer's song.

Usage rights generally belong either to Avon, or to another person (e.g. the photographer) who has given Avon permission to use the material, often only for a limited time, in limited places, or in limited channels, but such rights are not extended to Independent Avon Representatives. **Like our trademarks, no one can reproduce any part of these materials without Avon's permission.**

**AS A BASIC RULE,** please don't use a copy of brochures, product pictures or model photos, for example by downloading images from the Avon website or taking photos of the brochure.

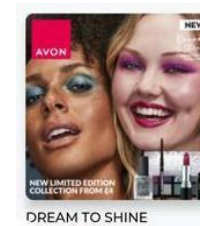

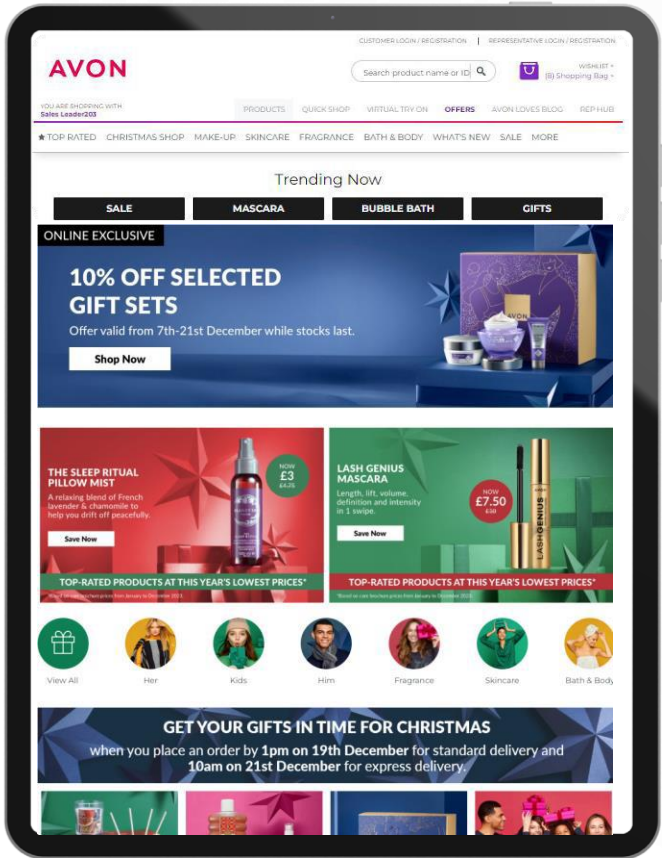

We support our Reps by offering a variety of online selling tools.

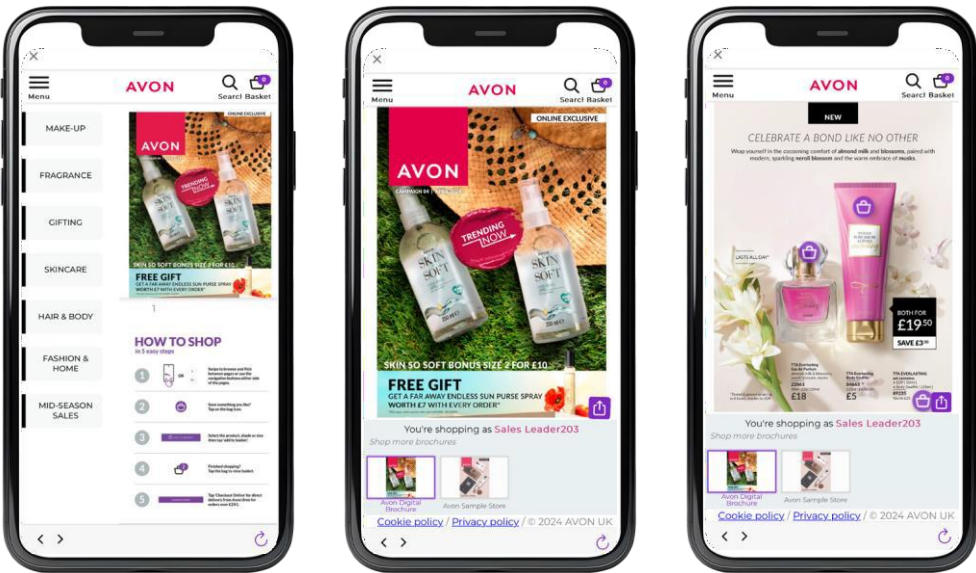
## Avon Official Website

allows you to share an interactive version of our brochure with your customers. They can click the products they want, and upon completion, a list of their order will be sent to your whatsapp.



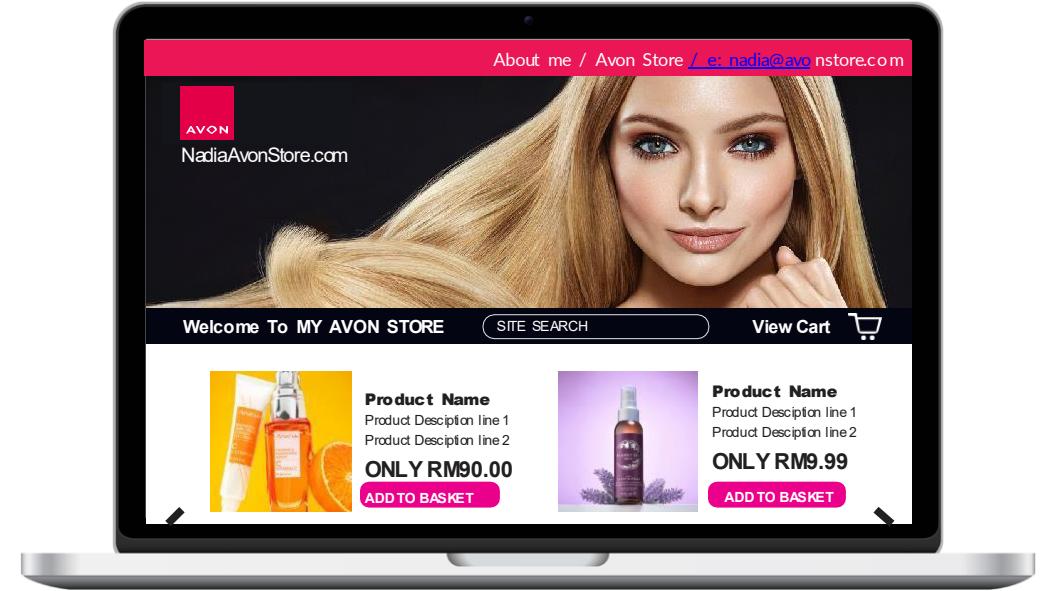


## IMPORTANT THINGS TO KNOW ABOUT SELLING AVON ONLINE

If you decide to create your personal website for selling Avon products, you should have your own design and “look and feel” to your website, and not mimic the look of the Avon website in a way that would lead a customer to think the website is managed by Avon. There will be certain criteria you need to meet, so read on to find out more. **The following pages will discuss further the right and wrong way to approach a personal website.**

# EXAMPLE 1 COMPLIANT WEBSITE

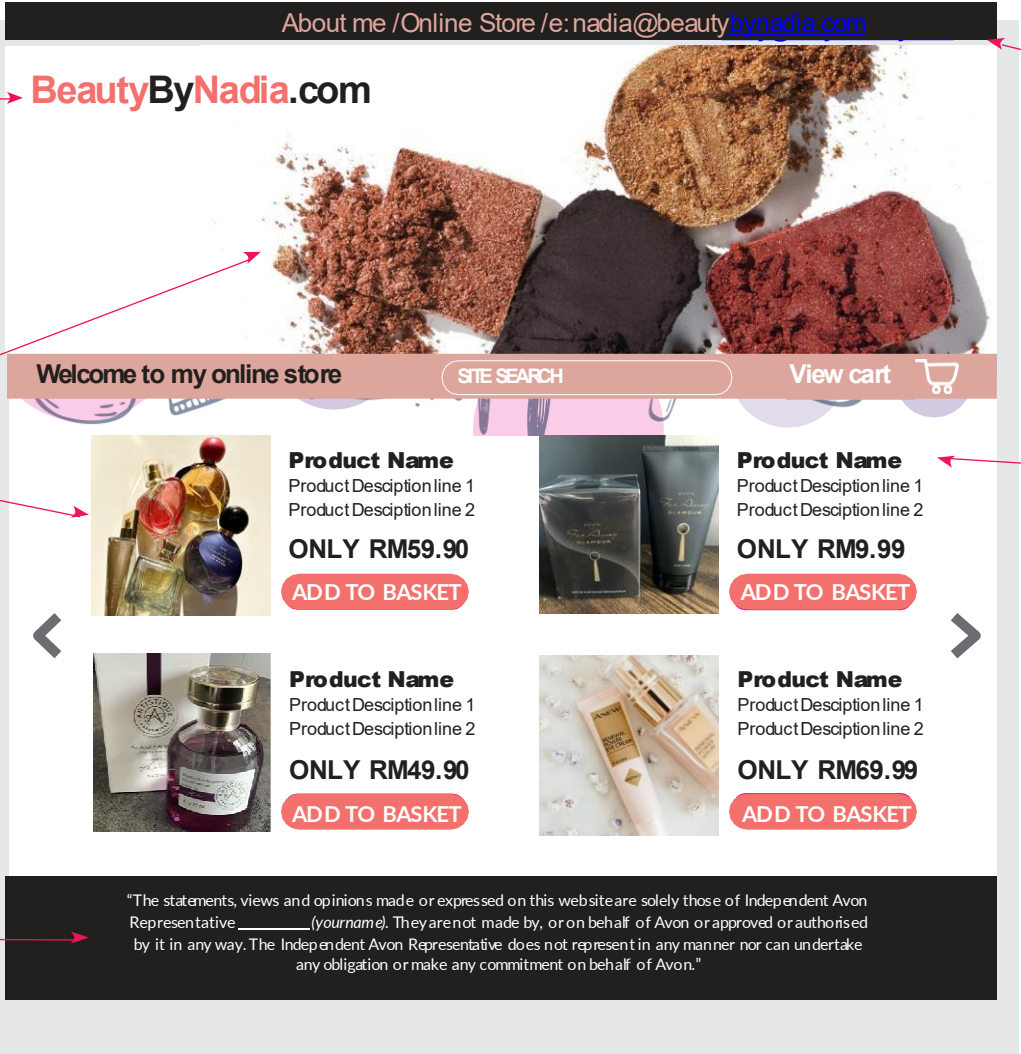
1. Use your own ~~original~~ name, not using the Avon name within this.  
Your website should look and feel like your website, NOT an Avon site.

2. Use your own product photography

3. Your website must include this disclaimer

4. Any email address that you advertise, or link to on a website, may not contain any Avon trademark or logo

5. When you advertise Avon products on your website, please make sure that you only use product related descriptions and statements which are included in official Avon communication





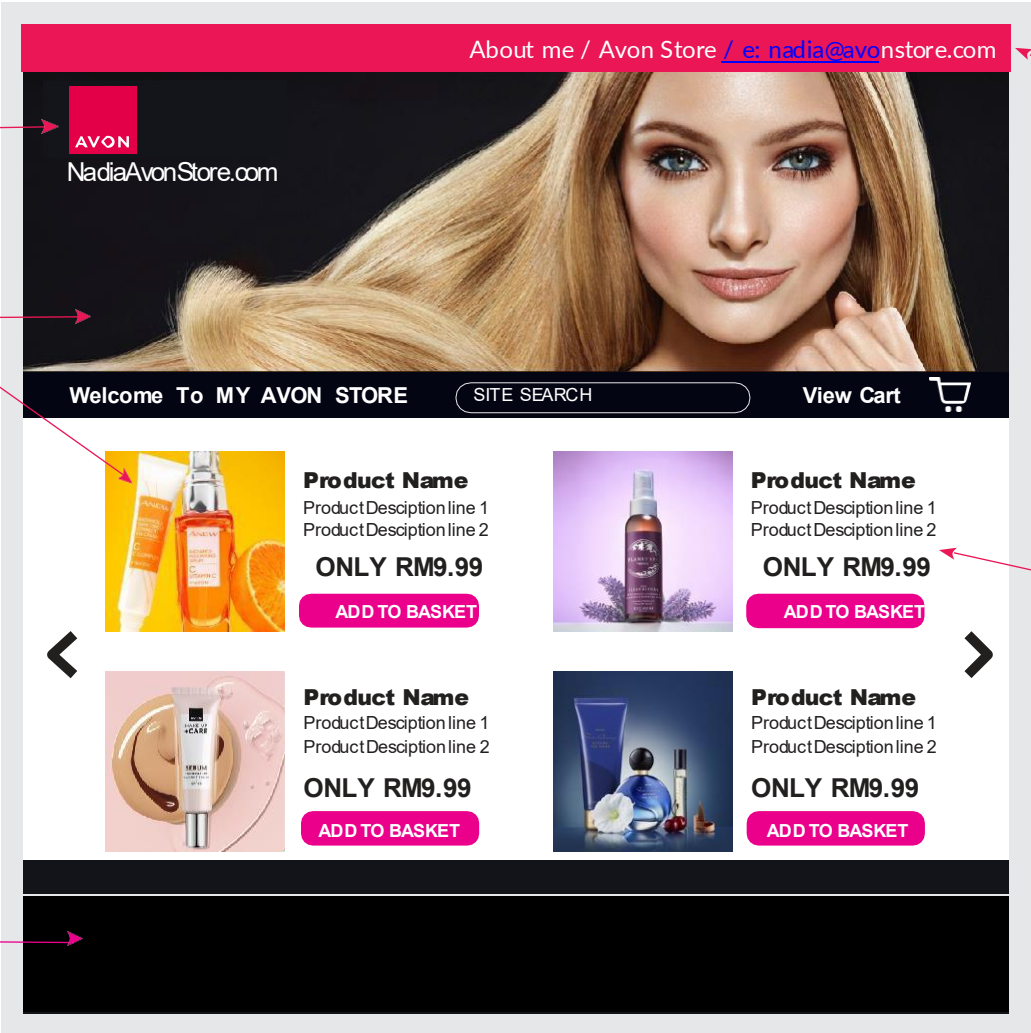
## EXAMPLE 2 NON COMPLIANT WEBSITE

1. Don't use the Avon brandmark, logo or Avon as a name in your domain names, URLs or email address.

2. On your website you cannot use copyrighted product or model images taken from the Avon website or brochures

Your website should NOT look and feel like an Avon website.

3. Your website MUST include the correct Avon disclaimer



4. Any e-mail address that you advertise, or link to on a website, may not contain any Avon trademarks.

5. When you advertise Avon products on your website, please make sure that you only use product related descriptions and statements which are included in official Avon communication



## THE CRITERIA YOUR ONLINE STORES MUST MEET:

**You may NOT use Avon's trademarks** (e.g. Avon as a name) in your e-shop, domain names, URLs, or email address.

**You may NOT use copyrighted materials** (e.g. product pictures taken from Avon brochures) on your website. You may only use Avon's Independent Rep logo, images or photographs that you obtain from the Rep Resources page, and within the specific scope depicted for such material (time frame and channel).

**Your website or e-store should look and feel like your website, NOT Avon's.**

At all times, it must be transparent who the customer is buying from: that the site is yours, not Avon's, and your contact details must be visible. You must disclose your relationship to Avon by placing the phrase **Independent Avon Rep** in a prominent location on such page, appearing in the same or larger font size as the surrounding text.

**Your website MUST include this disclaimer**

**"The statements, views and opinions made or expressed on this website are solely those of Independent Avon Rep \_\_\_\_\_ (your name).**

**They are not made by, or on behalf of Avon or approved or authorised by it in any way. The Independent Avon Rep does not represent in any manner nor can undertake any obligation or make any commitment on behalf of Avon."**

**When you advertise Avon products on your website, please make sure that you only use product related statements which are included in official Avon communications**, such as in the brochure or on the Avon website. Never use statements for Avon products which you have created on your own (e.g. "this mascara can last up to 3 days") because such statements require scientific/statistical proof and you will likely make a misleading marketing claim.

**Any e-mail address that you advertise, or link to on a website, may NOT contain any Avon trademarks.**

In addition, you should always indicate your status as an **Independent**

**Avon Rep** in your email signature when conducting business relating to Avon products or recruitment by email.



## PROMOTING YOUR WEBSITE ON OTHER PLATFORMS:

**Avon Reps are free to advertise their personal websites**, but if you choose to bid on “Avon” or any other Avon trademark as a keyword for an online Ad, you agree not to use the Avon trademarks in your advertisement headline, except where you are using it to make your status of **Independent Avon Rep** clear.

You may, however, use the Avon trademarks in any descriptive lines of the advertisement. Search engine advertising pointing to your personal website must clearly indicate that it was created by an **Independent Avon Rep** and not by Avon itself.

Where you are bidding on ads to your online store provided by Avon (My Avon Store/[local link]), you must make clear in the headline or descriptive lines of the ad that the customer will be shopping with you (an Independent Rep).

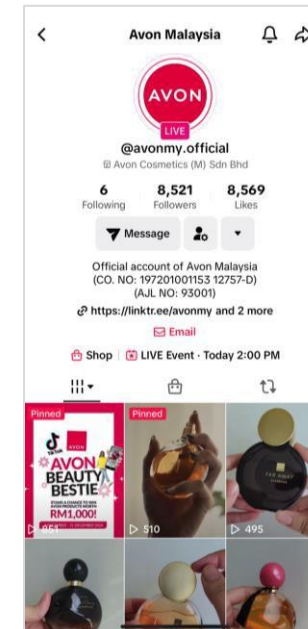
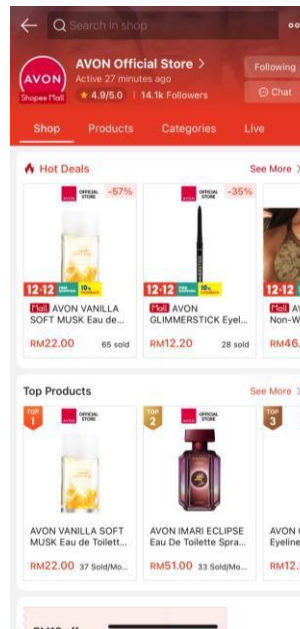
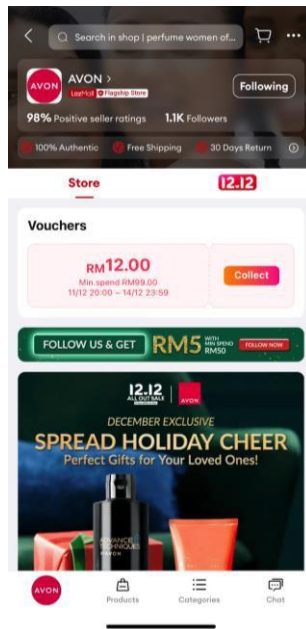
# **ONLINE MARKETPLACES & SOCIAL COMMERCE**



## Avon encourages Independent Avon Reps to carry out their Avon businesses online, including online marketplace selling.

In Malaysia, Avon Official Stores are already present on Shopee Mall, LazMall and TikTok. This means that any other sellers who wants to sell Avon will have to submit a Letter of Authorization from Avon that verifies their status as a registered online Rep (Wakil Avon Berdaftar). As a start, approval for Shopee, Lazada & TikTok is subject to Reps who fit the requirements mandated by Avon, the respective marketplace platform and the Ministry.

**If you decide to create your own unique listings on any of these marketplaces, you do so at your own risk.** Listings created by Reps may be removed by the platforms if found to be a duplicate or in breach of the marketplace rules and policies, including their Intellectual Property Policy.





## SELLING AVON ON ONLINE MARKETPLACES WITHOUT AN OFFICIAL AVON STORE

Whenever you'd like to sell Avon products on online marketplaces where Avon does not have an official brand store, be careful to follow these rules when creating your marketplace or auction listings.

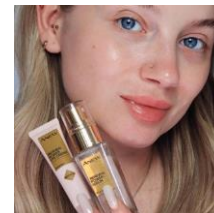
✓ **Use Avon's trademarks in a purely descriptive sense to describe the goods offered for sale. For example, "Avon True Colour Glimmerstick Eyeliner" in the listing headline.**

✗ **Do not use any unsupplied Avon trademarks or copyrighted work in your marketplace or auction listings**



If you create your own content and photos for use on your listings:

✓ **When online selling, your photographed product images should be clear and clean with a considered background and structure**



✗ **If creating your own content and photos, do not use photos that are busy, cluttered and unclear, because this may damage the perception of the Avon brand.**

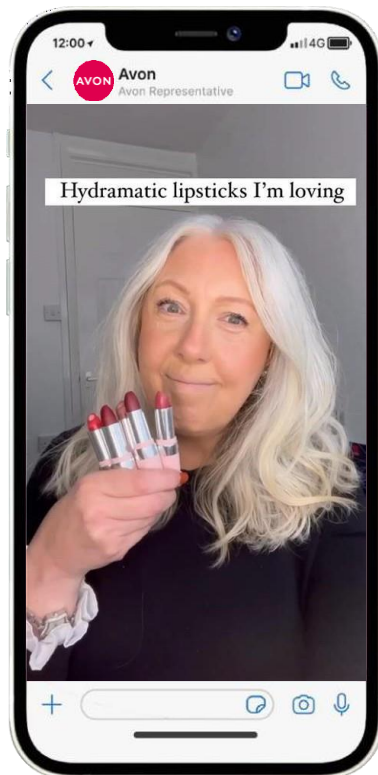

# BE SOCIAL MEDIA SAVVY



## REPRESENTING OUR BRAND ON SOCIAL MEDIA

Since sales of Avon products are based on personal relationships, and so much of that is conducted through social media, we encourage presence on social media, blogs, and similar sites. **Reps are encouraged to use social media** platforms like **Facebook**, **Instagram** and **TikTok** to spread their love of Avon, but must do it always in an honest and truthful manner in line with the following guidelines...

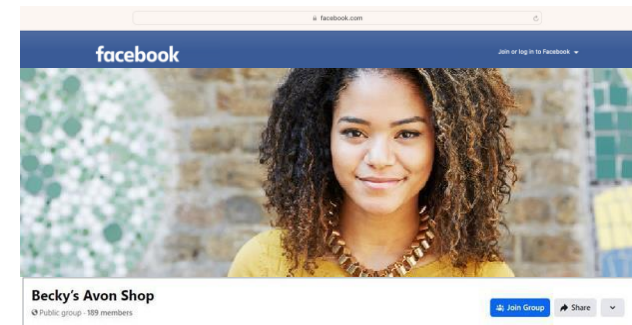




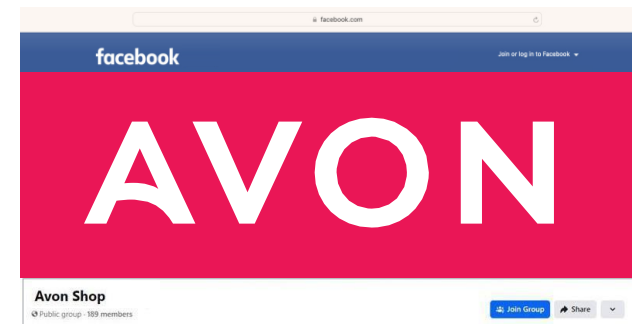
## SOCIAL MEDIA GUIDELINES:

1. Don't include Avon trademarks in your social media usernames or profile names, unless you're using 'Avon' to describe yourself as an **Independent Avon Rep**. This is because you **must not use the Avon trademark in a way to suggest that the social media account is created by Avon, or is an official Avon channel**.
2. When creating social media pages or groups, do not use the Avon trademark in a way that could mislead the consumer to believe it is operated by Avon or is an 'official' Avon group. A social media page or group name should not be named using the Avon trademark, unless accompanied by words that make it clear that the page is operated by an individual. **A social media (e.g., Facebook) group name and picture should clearly state that it is operated by an individual, e.g. 'Becky's Avon Shop' with Becky's own image.**

3. You may not use any **Avon trademark** logos, **copyrighted work**, or **Avon official product** and **model photos** as your profile picture or group profile picture.



✓ **CORRECT** Facebook page called **Becky's Avon Shop** with your profile picture or group picture.



✗ **NOT CORRECT** Facebook page called **Avon Shop** using Avon trademark logo or copyrighted work.



## SOCIAL MEDIA GUIDELINES:

**4. You may not copy any Avon image, whether obtained from an Avon website, or an internet search to include in posts online.**

However, you may link to content on Avon websites or, where available, use the sharing function on Avon's official websites or social media posts, to share images that Avon has posted publicly.

**5. Reps may post content such as audio or video recordings, or images**

taken during their meetings with customers as long as such posts do not violate a customer's privacy rights. **Reps may post content**

**such as audio or video recordings or images taken during their Avon meetings as long as such posts are preliminary approved by Avon.**

**6. When sharing Avon products on social media platforms and encouraging others to purchase, you must always be clear about your commercial relationship with Avon and your status as an Independent Avon Rep.** In many countries, you may be considered an influencer and so must be careful to follow the applicable advertising rules, for example by labelling your social content with 'ad', if it is not clear from your profile that you are recommending the product(s) in the course of your Avon business.

# WHY IS COMPLIANCE SO IMPORTANT?

**You will now understand how important Avon's brand is and will know that by following these Rules you will helping to protect our brand for the years to come.**

Avon must treat non-compliance of these rules seriously and may:

- Warn you where we find non-compliance of these Rules and ask you to correct it.
- Request that your advertisements, content, listings, websites and social media pages are removed by the domain owner.
- Treat consistent or serious breaches of these Rules as a breach of your Avon Agreement and, in the worst case scenario, terminate this Agreement.
